- To pay tuition fees as specified in your offer letter and to make suitable financial arrangements to enable payment of fees and expenses for the duration of the course.
- To abide by the East 15 Acting School Professional Code of Conduct
- To be bound by the relevant <u>Regulations of the University of Essex</u>
- Successful applicants to East 15 Acting School's BA Acting and BA Stage & Production Management to share the name with the Membership Co-Ordinator in order to support the Federation of Drama Schools Clearing process.

Applicants who will require a Tier 4 visa to study in the UK must:

- Provide any additional documents or evidence requested by the University of Essex by any deadline.
- Provide evidence of an English Language test accepted by the University of Essex if requested, by the stated deadline.
- Provide additional documentation to support the Tier 4 sponsorship if requested, by the stated deadline.

Tuition fees:

The tuition fee for your first academic year is confirmed in your offer letter, further details regarding fees and funding is available from the <u>University of Essex website</u>.

Deposit and Important deadlines:

The East 15 Acting School Course Deposit of £300 should be paid and the signed Admissions Agreement returned by the deadline stated in your formal offer letter. East 15 applicants are exempt from needing to pay the £1000 <u>tuition fee deposit</u> to the University of Essex.

All other conditions of your offer must be met by 31 August 2020 or by the deadline stated in your official offer letter. Failure to meet these deadlines, or any set for you to supply information to support your application, will result in your offer being withdrawn.

Undergraduate Students Only: You must meet any reply deadline given by UCAS. Applicants whose offers are rejected by default due to a missed deadline may not have their offer re-instated.
